Para 1.20	In early 2020 we continued to run the extant watercolours workshops, oil club, acrylics club, craft club and children's art club.  Because of the COVID-19 restrictions from March onwards, we had to restrict our workshops to a maximum of 6 persons (when able to open), which severely curtailed our income and the service provided to the community.  However, due to Government assistance and various grants, we were able to survive the time of limited operations. The new administration, with new vitalised Trustees, took over running the Charity in August; used the hiatus of the National Lockdown to refurbish the Centre, improve the working and display environments, and re-brand; the resulting Centre better serves the community and establishes a basis for an expanding more 'up market' operation.  We continue to work with like-minded organisations to address the needs of the community as they relate to all sectors of arts and crafts.  The charity has now firmly established itself, in its newly-refurbished shopfront facilities, as a 'go to' venue for artists old and young, expert and novice, and to all diverse and disadvantaged individuals.
