### LEGAL STUFF

- Newbiggin Arts Centre is a charity
- Charitable Incorporated Organisation with voting Members other than its charity trustees – 'Association' model \*
- <u>Not</u> 'Foundation' model, whose only voting members are the charity trustees themselves

## © Newbiggin Arts Centre SEMI-LEGAL STUFF

- Because NAC is 'Association' model \* only Trustees and Members should attend & be able to vote at AGM
- But we don't yet have any formal Members (other than Trustees)
- For openness & transparency, we have invited all 'associate' members (you!)
  but no formal voting rights

- Trustees intend eventually to implement a formal Membership (with annual/monthly membership fees), giving Members a right to access and use all our facilities and to vote at AGM

### FUTURE OF NEWBIGGIN ARTS CENTRE

- Expand scope

### RETIREMENT AND RE-ELECTION OF TRUSTEES

#### Constitution

13. Appointment of charity trustees

(2) At every annual general meeting of the members of the CIO, one-third of the charity trustees shall retire from office.

#### 16. Reappointment of charity trustees

Any person who retires as a charity trustee by rotation ..... is eligible for reappointment. A charity trustee who has served for three consecutive terms may not be reappointed for a fourth consecutive term, but may be reappointed after an interval of at least three years.
